The SCMA Fellow designation has been created to recognize career excellence. The award will be presented to a practitioner in Supply Chain who has made contributions to the industry, the profession, the association and their community over the course of time. Responses to the sections of the nomination form should include an indication of the time period (at least approximately) involved with the Nominee’s participation.

Section A: The Career Record

1. **The Profession** -- Describe how the nominee’s activities demonstrate leadership, significant participation or contribution in the development and-or advancement of the Supply Chain

2. **SCMA (National and/or Local Institute)** — Provides leadership, significant participation and/or contribution to SCMA and/or their Local SCMA Institute, in supporting the objectives of the National Association.....for example, through governance or volunteer activities of SCMA. 3. **Supporting Education & Research** — Provides leadership, significant participation and/or contribution in supporting the education and-or research activities in the field of supply chain management. In particular, this would include the development of new or updated teaching/training materials, and/or the delivery of SCM training programs. Please Note that education activities need not be exclusively for SCMA or SCMA Institute programs or courses – activities provided through other organizations or institutions will also be recognized for their contribution to the profession. 4. **As an Advocate** —The Nominee could be considered an Advocate for the Supply Chain profession, speaking positively and accurately to enhance the understanding of Supply Chain, the role it plays in the everyday needs and experiences of everyone, and in expanding upon the benefits that SCM provides to employers, and to community.
