

**APPLICATION REQUIREMENTS**

Prospective candidates who have strategic supply chain management knowledge obtained through completion of the CITT-Certified Logistics Professional (CCLP) designation **within the last 5 years** may apply for exemption for Module 3 – Logistics and Transportation. Upon proof of completion of CITT's Foundations of Risk Management and/or Negotiation strategies for Supply Chain Professionals courses, you will also be exempted from Workshops 2 and 5.

Along with this Application form, the following must be submitted to SCMA-National:

1. An official or certified transcript(s) of all CITT programs completed within the last 5 years.
2. Proof of completion of the CITT-Certified Logistics Professional (CCLP) designation.
3. Payment of the \$750 processing fee which will include one-year complimentary membership with SCMA.
